# How is the data collected?

Personal data may be collected as follows:

- Website
- E-mail
- Personally
- Reporting channel

The collected data is processed and stored on computer or physical support in accordance with current European legislation.

#### What is the purpose of the data collected?

The collected data is intended to be part of a personal database whose purpose is:

- To reply to contact requests;
- Recruitment;
- Submission of ideas within the Research, Development and Innovation Management System;
- To handle complaints submitted in the Reporting channel.

Our employees and service providers contracted by Celoplás Group are obliged to maintain confidentiality and comply with the provisions of the General Data Protection Regulation.

















#### Is your data shared?

The data collected and held by any company of Celoplás Group may be confidentially transmitted to the following entities:

- Celoplás Group Entities;
- Judicial or administrative authorities where this is mandatory;
- Subcontractors who will process data on behalf of the Group and in accordance with predetermined purposes.

# Where do we store your personal data?

The data we collect from you and for which we are responsible is stored in a location in the European Union.

# What is the data storage period?

The retention period of the collected and stored data varies according to the purpose of its processing. When/if there is no specific legal requirement, data shall be kept only for the minimum period necessary for the purposes for which it was collected. After this period data will be deleted.

# **Your Rights and Choices**

Celoplás Group respects your right to privacy and data protection: it is important that you can control your personal data.

You have the following rights:

YOUR RIGHTS	WHAT IT MEANS?
The right to be informed	You have the right to obtain clear, transparent, and easily understandable information about how we use your personal data and about your rights. That is why we provide you with information in this Policy.
The right of access	You have the right to access personal data we hold about you (subject to certain limitations).  We may charge a reasonable fee considering the administrative cost of providing information.  Manifestly unfounded, excessive, or repetitive requests may not be answered. To do so, please contact us using the details below.

















The right to rectification	You have the right to rectify your personal data if it is inaccurate or outdated and/or to complete it if it is incomplete.
The right to erasure or "right to be forgotten"	In some cases, you have the right to have your personal data erased or deleted. Please note that this is not an absolute right, as we may have legal or legitimate grounds for holding your personal data. If you want us to delete your data, please contact us using the details below.
The right at any time to withdraw consent to data processing based on consent	You may withdraw your consent to our processing of your data when such processing is based on your consent. The withdrawal of consent shall not affect the lawfulness of processing based on consent before its withdrawal.
The right to object to processing based on legitimate interests	You may at any time object to the processing of your data when that processing is based on a legitimate interest. We would refer you to the table inserted in the section "What data we collect and how we use it", especially the column "What is the legal basis for processing your data?" to identify when our processing is based on legitimate interests.  To do so, please contact us using the details at the end of this Policy.
The right to lodge a complaint with the supervisory authority	You have the right to contact the data protection authority in your country (in Portugal it is CNPD) to file a complaint against the unauthorized data protection and privacy practices of Celoplás Group.  Do not hesitate to contact us for the data below before submitting any complaint to the competent data protection authority, namely the National Data Protection Commission.
The right to data portability	You have the right to move, copy or transfer data from our database to another. This only applies to data you have provided when the processing is based on your consent or contract and carried out by automated means. We would refer you to the tables inserted in the section "What data we collect and how we use it", especially the column "What is the legal basis for processing your data?" to identify when processing is based on the performance of a contract or on consent. For more information, please contact us using the details at the end of this Policy.

















The right to restriction	You have the right to request the restriction of the processing of your data. This right means that our processing of your data is restricted, so we can store it, but we cannot use it nor subject it to further processing. It applies in limited circumstances listed by the General Data Protection Regulation.
The right to disable Cookies	You have the right to disable Cookies. Internet search engine settings are normally programmed to accept Cookies by default, but you can easily adjust them by changing your search engine settings.  Many cookies are used to improve the use and functionality of websites/applications.  If you wish to restrict or block all cookies that are set by our websites/applications (which may prevent you from using certain parts of the website), or any other websites/apps, you can do this through your search engine settings, whose explanation is set out in this Policy.
